**Who's eligible:** Anyone whose home was damaged due to flooding, and that your home is located in Rock Rapids, Iowa.

**How to apply:** The quickest way is to fill out an application form and email it to [chamber@rockrapids.com](mailto:chamber@rockrapids.com). This grant will be reviewed based on need and the amount of grant funds available.

**Deadline:** Applications are due by 12 p.m. on Monday, August 12th, 2024.

When an unforeseen event occurs that negatively impacts families, the Rock Rapids United Fund provides support and resources needed to get them through this difficult time. Because of the disruptions that the flooding has created to our community, the **Rock Rapids Flood Relief Program** was created. It allows impacted families to access grant funds to make repairs to your damaged home.

To be eligible for the Rock Rapids Residential Housing Flood Relief Program, a family must:

1. Demonstrate a loss due to flooding.
2. Remain a resident of Rock Rapids.

**Applicants:** *The Rock Rapids Residential Housing Flood Relief Program has limited funds and is focused on assisting Rock Rapids families disrupted due to flooding. Grant funding depends on funds available and number of applicants. We will do the best we can to assist our community in this time of need.*
